#### 1. JURISDICTION

This event is a ClubSport Advanced Event promoted by MotorSport Bay of Plenty Inc at Te Matai Motorsport, TECT Park, Pyes Pa.

The Meeting will be held under these Supplementary Regulations, the MotorSport NZ National Sporting Code and its Appendices and Schedules particularly Appendix Five, Schedule C being the Standing Regulations for all ClubSport Events and Appendix Two, Schedule A – Driver and Vehicle Safety Requirements.

#### 3. EVENT DESCRIPTION:

##### 3.1

5km Gravel bent sprint; 4km of gravel surface forest road and 1km clay-based autocross track (weather dependent) for the day runs. The course is 4km of gravel surface forest road for the night runs. This event is three events in one. There will be one recce session for both day and night runs. The Day Sprint will be three runs. The Night Sprint will be two runs. For the Day/Night Challenge, Day and Night best times will be combined to provide an overall time for the Challenge. Competitors may choose to do only the daylight runs.

**Classes:** Vehicles will be divided into the following classes. **NOTE: For safety reasons Cross Cars will not be accepted as entries to this venue.**

A	0-1600cc
B	1601-2000
C	2001-3500cc
D	3501 and over
E1	4WD pre year 2000
E2	4WD year 2000 and over

#### 4. ENTRIES:

##### 4.1 Registration of Interest/Entries is available through the MotorSport Online system

The Club requires that entries are made online.

Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.

##### 4.2 Opening and Closing Dates:

Entries open with the publication of these regulations and close (at normal fees) on Wednesday 28 August 2024 at Midnight.

**Entries must be received online by midnight 28 August 2024. For timing purposes, we need to know how many competitors will be at the daylight runs.**

Entries received after the normal fee-closing date are subject to late fee.

#### 5. COMPETITOR REQUIREMENTS and UNDERSTANDING:

##### 5.1 Licence Requirements:

All drivers must hold as a minimum an M Grade Competition Licence and current membership with a member club.

If the Entrant is other than a driver, an Entrants licence in the name of the Entrant is required.

##### 5.2 Competitor Understanding:

In submitting the entry competitors (Entrant and Drivers) are deemed to fully understand the MotorSport NZ National Sporting Code and its relevant Appendices and Schedules. In particular:

- The National Sporting Code Articles pertaining to protests and competitors' obligations, and
- Appendix Five, Schedule C.

##### 5.3 All competitors shall wear safety apparel in compliance with Appendix Two, Schedule A.

#### 6. ELIGIBLE VEHICLES

##### 6.1 Compliance: All vehicles shall comply with Appendix Five Schedule C and Appendix Two Schedule A of the current MotorSport Manual unless stated otherwise in these supplementary regulations.

**9. GENERAL INFORMATION**

**9.1** **Passengers:** May only be carried in accordance with Appendix Five, Schedule C Article 6.2.

**9.2** Alcohol is not permitted to be consumed by any competitor or their crew at the event before or during the day's competition.

**9.3** Marshals will be needed to help. All marshals will be provided with food. It would be appreciated if competitors were able to bring someone to assist with marshalling.

**10.1** There are no COVID-19 Protocols required.
